Cookies, Web Beacons, and Similar Technologies

Security Measures and Retention Period

We have implemented technical, administrative, and physical security measures to safeguard the security of your personal data in accordance with legal standards.

Your data will be retained for a period of 60 months, in alignment with the purposes outlined in this notice and the corresponding legal statutory periods.

Purposes of Personal Data Processing

We will use the collected data for the following purposes, which are necessary to provide the requested service:

- d) Purpose of establishing a commercial relationship

Data Transfers Performed

We will not share your personal data with third parties, except as required by law. The data will be used exclusively for the purposes specified in this Privacy Notice.

Means to Exercise ARCO Rights (Access, Rectification, Cancellation, or Opposition)

You have the right to know what personal data we hold about you, as well as how it is used and the conditions under which it is processed (Right of Access). Likewise, you have the right to request the correction of your personal information if it is outdated, inaccurate, or incomplete (Right of Rectification); to request the removal of your data from our records or databases if you consider that its use does not comply with the principles, duties, and obligations established by regulation (Right of Cancellation); as well as to object to the processing of your personal data for specific purposes (Right of Opposition). These rights are collectively known as ARCO rights.
